



RIVERLINK RETAIL PRECINCT CONDITIONS OF ENTRY

In order to maintain a quality family environment for customers and visitors to the Riverlink Retail Precinct the following Conditions of Entry have been adopted.

1. It is a condition of entry of any person to the Riverlink Retail Precinct (and any vehicles parking in the car parks) that these Conditions of Entry are agreed to and shall bind any such person so entering. Should any person not agree with any of the Conditions of Entry then that person should immediately leave the Riverlink Retail Precinct.
2. The Riverlink Retail Precinct is private property and the Company reserves the right to refuse admission of any person to the Riverlink Retail Precinct and to require any person to leave the Riverlink Retail Precinct at any time and for any reason whatsoever.
3. In any event any violation of the Conditions of Entry shall subject the person involved and any vehicle parked by such person to immediate removal by the Company from the Riverlink Retail Precinct.
4. No person entering the Riverlink Retail Precinct shall behave in a manner which detracts from the quiet enjoyment of the Riverlink Retail Precinct by any other person visiting or shopping at the Riverlink Retail Precinct or which in the opinion of the Company may lead to a breach of the peace without limiting the generality of the foregoing:
 - a. Appropriate attire shall be worn at all times in or about the Riverlink Retail Precinct – shoes and shirt must be worn at all times;
 - b. Skateboards, rollerskates, rollerblades or similar shall not be used or ridden in or about the Riverlink Retail Precinct.
 - c. Animals other than assistance dogs shall not be brought to the Riverlink Retail Precinct.
 - d. Bicycles shall not be wheeled or ridden inside the centre, but shall be parked at bicycle racks designated by the Centre.
 - e. School children are not permitted in the Centre during school hours (8.30 am to 3.30 pm) on gazetted school days.
5. Any person who damages or causes any damage to any other person, property or goods at the Riverlink Retail Precinct shall be liable for all direct, indirect, consequential or special loss or damage sustained by that other person or by the owner of such property or goods AND indemnify the Riverlink Retail Precinct against any claim which may be brought against the Company or the registered proprietor of the Riverlink Retail Precinct in respect thereof.
6. Access to the Riverlink Retail Precinct is restricted to persons visiting, shopping at or doing business in the Riverlink Retail Precinct. Our carparks are reserved for such person, but only whilst they remain on our property.
7. No leaflets or brochures shall be either affixed to vehicles, property or otherwise distributed at the Riverlink Retail Precinct without the prior written approval of the Company.
8. No Hawkers allowed in and around the Riverlink Retail Precinct.
9. Loitering in and around the Riverlink Retail Precinct and car parks is prohibited.
10. Wherever the word “Company” is referred to in the Conditions of Entry it shall mean Lipoma Pty Ltd A.C.N. 002 203 581 the Manager of the Riverlink Retail precinct duly appointed by the registered proprietor and unless repugnant to the context it shall be deemed to include all employees, servants and agents thereof.
11. The words “Riverlink Retail Precinct” referred to in these Conditions means the Ipswich Riverlink Shopping Centre complex, roadways and carparks.
