

### **Riverlink Community Grant**

1. The promoter is Riverlink Shopping Centre A.B.N No 69 704 114 267, Cnr Downs Street and The Terrace. PO Box 2155, North Ipswich, 4305, Queensland AUSTRALIA.
2. 3 x \$300 Community Grants are offered each month by Riverlink Shopping Centre to assist local community, not-for-profit and charity organisations, sporting groups and community groups.
3. Each \$300 Community Grant is in the form of a \$300 Riverlink Gift Card.
4. Applications for the Grant must be made in writing and received by the end of each month in order to be considered for that months Grant.
5. Grants will be made each month of each year until Riverlink management decide to discontinue the program. Applications for Grants received after such time as the program is discontinued will be destroyed and applicants will be advised accordingly. Promotion for the Grants will, at the time of discontinuation, cease and will be removed from the Riverlink website.

7. Only groups and organisations operating in the Ipswich City Council area will be considered for the Community Grant.
8. Employees of Riverlink Shopping Centre Management are ineligible to apply however groups or organisations they are associated with are eligible to apply.
9. Each application will be considered on it's merit and the Grant will be awarded at the discretion of Riverlink Centre Management.
10. Riverlink Centre Management reserves the right not to offer any explanation as to why or why not an application was either successful or unsuccessful.
11. Successful applications will be contacted by the contact details provided on the application form. Unsuccessful applications will not be contacted.
12. Unsuccessful applications will need to reapply for their organisation to be considered for further Riverlink Community Grants.
13. The Promoter reserves the right, at any time, to verify the validity of applicants and applications and to disqualify any application which is not in accordance with these Terms and Conditions.
14. If a Grant is not claimed within three months that Grant will be forfeited.
15. In circumstances where the successful applicant is unable to be contacted on the telephone number and e-mail address provided the Promoter reserves the right to disqualify that application and select an alternate application in accordance with these terms and conditions.
16. If, for any reason, the successful applicant does not use the entire amount of the Riverlink Gift Card at the specified time or within the time stipulated for the use of the Gift Card then the Gift Card will be forfeited by the applicant and cash or other prizes will not be offered in replacement.

17. By entering this Promotion, applicants are providing consent for the Promoter to hold and use their personal information. The Promoter collects personal information in order to conduct the Promotion and may, for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities. Entry is conditional on providing this information, which will be added to the Promoter's database.
