

RIVERLINK FUN PASS PROMOTION
Friday 13th Dec 2024 to Friday 24th Jan 2025
Terms and Conditions including the Privacy Statement

1. Information on how to participate form part of these Terms and Conditions. Participation in this “RIVERLINK FUN PASS” (“Promotion”) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are expressed in Australian Eastern Standard time (AEST).
2. The “Promoter” is Riverlink Shopping Centre ABN 65 002 203 581 at Cnr Downs Street & The Terrace, North Ipswich QLD 4305 (**Promoter**).
3. Subject to clause 4, this Promotion is only open to Qld residents aged 18 years or over, unless the participant has been given permission by parent or guardian to participate in the Promotion. If a recipient is under the age of 18 years, the parent or guardian who gave permission for participation in the Promotion is deemed to be the recipient for the purposes of the Promotion.
4. The following are ineligible to participate: (i) employees of the Promoter or any of the tenants or retailers in Riverlink Shopping Centre or any of the Promoter’s agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter’s Promotions.

This Promotion commences and Fun Passes are available to purchase between 10.00am – 2.00pm from Friday 13th December 2024 until 2.00pm Friday 24th January 2025 (Sale Period – excluding Christmas Day) or until tickets are sold out. The tickets are VALID from 10.00am Friday 13th December 2024 until 9.00pm Friday 7th February 2025 (Promotion Period). The Promoter may extend the Promotion period at its sole discretion (Extended Competition Period). Details of any Extended Competition Period will be posted on www.riverlink.net.au. References in these terms and conditions to the Promotion Period include any Extended Promotion Period, where applicable.
6. Once the following ticket allocations are sold out during the Promotion Period, no further tickets will be available for purchase. The Promoter has the right to increase or decrease ticket allocations during the Sale period.
 - a. Limelight Cinemas Fun Pass x 2,150 tickets
 - b. iPlay Bowling Fun Pass x 1,075 tickets
 - c. iPlay Arcade Fun Pass x 1,075 tickets
 - d. Riverlink Dining Fun Pass x 2,150 tickets
7. The Riverlink Fun Passes can only be used during the Promotion Period or Extended Promotion Period.
8. For a customer to purchase a Riverlink Fun Pass they must purchase their passes at the customer service booth located outside The Athlete’s Foot. A limit of 6 individual Fun Passes will be available for purchase per person.
9. The costs for each ticket type are listed below. Prices are inclusive of GST.
 - (a) Limelight Fun Pass will cost the participant \$8.00 AUD.
 - (b) iPlay Bowling Pass will cost the participant \$7.50 AUD.

- **TOTAL MINIMUM RRP VALUE: \$20.00 AUD**

11. To redeem the vouchers:
 - (a) Participants visit the participating retailers with their purchased fun pass or follow the booking instructions on the back of the vouchers
 - (b) Only original vouchers will be accepted. No replicas or photocopies of the vouchers will be accepted
 - (c) Vouchers cannot be used in conjunction with any other offer at Riverlink Shopping Centre and/or participating retailers
 - (d) Vouchers are not redeemable for cash
 - (e) No refunds will be issued for any unused portion of the vouchers
 - (f) Participants must abide by the individual Terms and Conditions pertaining to each individual voucher
12. The Promoter assumes no responsibility for lost, misplaced, destroyed or stolen Riverlink Fun Passes once they are claimed.
13. A limit of vouchers is available for purchase each day:

 - (c) 25 x iPlay Arcade Passes
 - (d) 50 x Riverlink Dining Passes
14. The Promoter reserves the right to refuse or cancel a Riverlink Fun Pass to any person.
15. The Promoter and participating retailers shall not be liable for any loss or damage whatsoever which is suffered or for personal injury which is suffered or sustained as a result of utilising the Riverlink Fun pass except for any liability which cannot be excluded by law.
16. Nothing in these terms and conditions is intended to exclude, restrict or modify rights which you may have under law (including the Australian Consumer Law ('ACL'), and consumer guarantees relating to goods or services under the ACL which may not be excluded, restricted or modified by agreement ('Your Consumer Rights'). Subject to Your Consumer Rights, the Promoter is not liable for any loss or damage however caused (including by negligence), suffered, or incurred in connection with the Promotion or Riverlink Fun Pass. Any condition or warranty which would be implied by law into these terms and conditions is excluded.
17. The Promoter may cancel the Promotion and not provide the Riverlink Fun Pass where circumstances beyond the Promoters' reasonable control prevent the Promoter from providing the Riverlink Fun Pass. Should the Promoter cancel the Promotion the Promoter will:
 - (a) Advertise that the Promotion has been cancelled by placing a notice at the Customer Service Booth located outside The Athlete's Foot and online at www.riverlink.net.au

18. The Promoter may also at its absolute discretion at any time change, amend or vary these terms and conditions, including the inclusions and pricing of the Riverlink Fun Pass.
19. The Promoter collects personal information ("PI") in order to conduct the promotion and may, for this purpose, disclose such PI to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities. Entry is conditional on providing this PI. The Promoter will also use, and handle PI as set out in its Privacy Policy, which can be viewed at <https://www.riverlink.net.au/privacy-policy/>. In addition to any use that may be outlined in the Promoter's Privacy Policy, the Promoter may, for an indefinite period, unless otherwise advised, use the PI for promotional, marketing, publicity, research and profiling purposes, including sending electronic messages or telephoning the entrant. The Privacy Policy also contains information about how entrants may opt out, access, update or correct their PI, how entrants may complain about a breach of the Australian Privacy Principles or any other applicable law and how those complaints will be dealt with. All entries become the property of the Promoter. The Promoter will not disclose PI to any entity outside of Australia.
